

TEAMSTERS STRIKE AMAZON Joint Council 7 Local Unions out in force on picket lines

In December, the Teamsters launched the largest strike against Amazon in U.S. history. The nationwide action followed Amazon's repeated refusal to follow the law and bargain with the thousands of Amazon workers who've organized with the Teamsters, including Teamsters at San Francisco's DCK6 Amazon warehouse who demanded union recognition last fall.

In addition to the picket line in San Francisco, Teamsters from every local union in Joint Council 7 participated in around-the-clock picket lines at 10 Amazon fulfillment centers throughout the Central Valley and Northern Nevada.

Nearly 10,000 Amazon workers have joined the Teamsters nationwide as part of a growing grassroots movement to secure strong union contracts and take control of their own lives. On the picket line, they are fighting for increased wages, improved benefits, and safer work conditions.

2025: Our year of investment

ovember 5 came with a mixed bag of results and a lot of mixed emotions. But no matter how anyone feels about the results of the election, we should take a moment to applaud ourselves for electing some very Teamster-friendly candidates in Joint Council 7's jurisdiction. We elected Teamster Local 856 members who ran for city council seats in Alameda County, we won tax measures to support our public sector members, and we flipped a Congressional seat in the Central Valley.

A big shoutout goes to Local 948, who had soon-tobe-Congressman Adam Gray working out of their office during the election. This was one of the most closely watched Congressional races, and a place where our volunteers mattered most, as Gray won and flipped this seat by fewer than 175 votes.

This election season every Local participated in candidate interviews, volunteered for different candidates or ballot measures important to their Local, encouraged their members to vote, and signed up DRIVE members—some locals even tried something new. In Northern Nevada, Local 533 ran an independent expenditure committee, Working Families for Washoe County, and won all but one of their local races. The participation of members like you is what makes or breaks elections, and ultimately local elec-

tions will have a direct impact on our day-to-day lives. Member participation allows us to invest in the future, as many of our endorsed local candidates will eventually run for higher office. The better local candidates we have, the better state and federal candidates we will have down the road.

Now that the election is over, the real work begins. Our Joint Council will continue to fight for worker protections when it comes to automation, our pensions, misclassification, and other issues that impact our day-to-day working conditions. We plan to run a strong Worker Protection Package of bills in Sacramento through the California Teamsters Public Affairs Council, and to work to strengthen our war chest for the next California gubernatorial election in 2026 by doing a big DRIVE push in 2025.

2025 will be our year of investment. We'll invest in our future by showing up for lobby days to pass our Worker Protection Package of bills, contributing DRIVE to ensure we have the funding to elect in a new Governor who supports workers in 2026, and participating in political actions to protect our jobs and to support our fellow Teamsters who are fighting for the right to organize or for a fair contract. We agree that we need to invest in ourselves-and that means investing in protections for Teamsters and our work. As 2024 comes to an end, I look forward to investing in our future with you in 2025!

SFO Airport Bag Handlers are Now Local 665 Members

Further north, agents, drivers, security ambassadors, and supervisors at Bags, a subsidiary of the Metropolis Company, at the San Francisco International Airport (SFO) have joined Teamsters Local 665.

They work alongside other Local 665 members who told them about how life changing Teamsters representation is," said Tony Delorio, Secretary-Treasurer of Local 665. "It's becoming common knowledge to workers in all sectors that Teamsters membership is key to bringing improvements and dignity to their workplace."

The 40 new Teamsters work as Remote Airline Check-In (RAC) workers, processing air traveler baggage at SFO's parking garages, rental car facility, and at the Air Train. and other locations add to the strength of the Teamsters. Our division will be there to back up successful organizing campaigns, from start to finish," said Rocco Calo, Director of the Teamsters Industrial Trades Division.

New Teamsters Provide Access to Public Transit in Underserved Communities

In San Francisco, drivers at Via Transportation, a contractor for the San Francisco Municipal Transit Agency (SFMTA), have finalized a successful card-check organizing effort to join Teamsters Local 665. The new partnership between the Teamsters and the SFMTA will play a key role in launching the Bayview Shuttle, which will create public transit access to members of the Bayview neighborhood of San Francisco.

"We are proud to be part of this transit launch that brings expanded service to residents in the Bayview community," said Tony Delorio, Secretary-Treasurer at Local 665. "San Francisco's southeast neighborhood has high density union households, and this new service will benefit workers and community residents alike. This is a great opportunity to bring mobility to seniors, workers, and youth while at the same time creating new employment opportunities for Teamsters."

The card check for representation was conducted by San Francisco Supervisor Shamann Walton, a longtime champion of transit expansion to underserved neighborhoods. Walton represents District 10, which includes the Bayview community. Launched in November, the Bayview Shuttle brings public transit access to communities that historically lacked adequate connections to metropolitan and regional public transit services. The SFMTA has announced that additional communities in San Francisco may soon enjoy expansion of the program.
